If a bidder (Here in referred to as second, party) to whom works/supply has been offered at the rates quoted by him, fails to complete the works/supply within stipulated period from the date of issue of 'Works/Supply Order', EMD submitted by him shall be forfeited to the revenue of the 'Institute' and offer shall be made to the next higher bidder at the cost and risk of the defaulting bidder.
- c.
